
Colonie Senior Service Centers, Inc. (CSSC) was established in October 1981 as a 501(c)3 not-for profit corporation. For forty-one years, we have been serving seniors and their families continuously, facing whatever challenge we were presented. Our mission is to provide comprehensive programs and services to those in the community who are in or approaching their mature years, as well as their families and caregivers. Through these services, CSSC always strives to ensure the physical, mental, emotional and financial wellbeing of all participants, while improving their quality of life, and enhancing the structure and stability of our community as a whole.

As we entered 2022, the expectation was to return to normalcy. However, this is not what CSSC experienced. We were challenged with an incredible demand and overwhelming need for our established senior programs and services. Adults who had been isolated for two years due to the pandemic were eager to re-engage.

With tremendous support from many, CSSC's Programs and Services met the demand. Classes and trips for THE CENTER at CSSC grew and continually sold out in record time. The number of seniors coming to Senior Community Dining to enjoy a meal and socialize jumped dramatically. The Bright Horizons Adult Day Services ran at capacity, providing support to seniors in need and their families. The Umbrella Program of Colonie continued to provide home maintenance to hundreds of seniors who choose to reside in their homes. CSSC's Transportation Services continued to help seniors get to medical appointments, senior dining sites, social adult day service programs, volunteer sites, their pharmacy and grocery store, religious, cultural, social and life-long learning activities, as well as other errands and events. Our RSVP volunteers returned in droves to various community, cultural and educational organizations, to once again help our community.

Colonie Senior Service Centers, Inc. would not be as successful without the support of the many financial contributions we receive. Thank you to all our 2022 supporters, who without your understanding, our mission and impact in the community would not be as strong.

Innovations, Accomplishments and Achievements

In 2022 Colonie Senior Service Centers, Inc. (CSSC) . . .

- Collaborated with the Regional Food Bank of Northeastern NY to continue supporting seniors facing food insecurity by holding a monthly open community food bank at The Beltrone Living Center. CSSC distributed over 12,000 pounds of food to hundreds of seniors from September through December.
- Was chosen by Goldstein Auto Group to be a part of their Subaru Share the Love campaign, raising over \$8,000 for CSSC programs and services.
- Held various monthly “Drive-Thru Dinners” and serving over 1,500 meals that benefited our senior community and raised funds for CSSC programming.
- Enjoyed sponsored CSSC Healthy and Local Cooking Classes, allowing seniors to learn to cook and prepare recipes from local chefs at the King Thiel Senior Community.
- Was once again voted one of the ten non-profits to win \$10,000 of free advertising in the Times Union Capital Region Gives Giveaway. This award is appreciated as it is won by the community supporting and voting for Colonie Senior Service Centers, Inc.
- Used music as a gathering beacon for our senior community, as CSSC held numerous concert series during 2022.

The World Concert Series in the spring of 2022, allowed seniors to enjoy Triskele and Irish/Celtic all-female band in March; Polish Night with Fritz’s Polka Band, in April; The Good Times entertained in May, for Italian Night and German Night in June heard the sounds of the Accord-A-Tones. This series was made possible through funding from the New York State Council on the Arts and the Arts Center for the Capital Region.

Music Mondays at The Beltrone, a three-week free concert series in July brought the sounds of the Standard Time Trio, Roben and Kosek Jazz and Blues and Band of Gold returned to CSSC and the senior community. This concert series was made possible with funding from Albany Musicians’ Association and Organize Senior Moves.
- Organized the Forever Young Singers, a group of Capital Region seniors who are led by Jeff and Crystal Moore of Peak Music. Many of these senior singers have no prior experience and just have fun getting together each and every week to sing Rock and Roll music. During 2022, they performed at: CSSC’s Summerfest; Colonie Center; Cohoes Music Hall Visitor Center; Christmas Land and at The Beltrone Living Center. The Forever Young Singers are made possible by the sponsorship from Highmark Blue Shield of Northeastern New York.
- Created “A Moment in Time”, an oral history pictorial project that has been exhibited throughout the Capital Region. Realizing how detrimental and isolating the COVID-19 pandemic was to everyone throughout the Capital Region, this project with a committed team of photographers, oral historians and make-up artists, along with CSSC staff captured and highlighted the insight and hope from 99 Capital Region seniors for the future. This project was made possible with funds from the Decentralization Program, a recent program of the New York State Council on the Arts with the support of The Governor and the New York State Legislature and administered by The Arts Center of the Capital Region.
- Received a grant to support transporting seniors to restaurants, cultural and educational venues, parks and so much more. The Michele L. Vennard Hospitality Grant Program of the Albany County Convention and Visitor’s Bureau Fund, a fund of the Community Foundation for the Greater Capital Region, that was established to support the Albany County hospitality industry by funding programs that will help build and sustain Albany County Tourism destinations, attractions and events and bring more visitors to the County.
- Received from Honest Weight Food Co-Op and their patrons over \$5,000 as their recipient of their May charity fundraiser.
- Collaborated with The Albany Field Office of the U.S. Committee for Refugees and Immigrants (USCRI) to help integrate senior refugees by offering free English as a Second Language classes twice a week, exposing them to cultural events and programming through CSSC’s senior community dining programs, community concerts, and THE CENTER at CSSC.
- Created “The Meals that Care Initiative”, in response to on-going community requests for food assistance. This program provides meals to homebound, vulnerable or ill seniors living within a 5-mile radius of The Beltrone Living Center. The goal is to deliver meals to seniors, for the short-term, who are truly struggling, are in recovery and/or unable to cook for themselves until they are able to care for their own needs again. This program is made possible with the support of Goldstein Auto Group, the Estate of Larry Siegel, Highmark Blue Shield of NENY and a grant from the Albany County Legislature.
- Was honored to receive from Rivers Casino and Resort and their patrons over \$4,000 as their chosen not-for-profit in their month of December “Making a Difference Campaign.”
- Were grateful to Assemblyman Phil Steck for his hard work and dedication to our senior community in securing \$150,000 in state funding to allow CSSC to purchase vehicles for our fleet.
- Received a \$2 million grant from the Assembly of the State of New York, Speaker Carl E. Heastie and Assemblyman Phil Steck to support capital costs associated with the proposed King Thiel II Senior Community.





Bright Horizons Adult Day Services

The Bright Horizons Adult Day Social Program provides a safe place for loved ones who need a supportive environment during the day and respite for their caregivers. Bright Horizons partners with families to offer a program that includes companionship, hot meals, exercise, recreation, and socialization. Bright Horizons also offers a virtual option to join our program two days a week and trained adult day social respite volunteers to provide programming in the home. Bright Horizons has provided more than 15,000 hours a year of respite to caregivers throughout the Capital Region.

Bright Horizons program activities include music therapy, pet therapy, Tai Chi, giant crossword puzzles, memory/trivia games, word games, arts and crafts, discussion groups, flower arranging, field trips, virtual travel, storytelling, baking group and a walking group. Activities vary based on the interests of the members. We are committed to continue our mission of providing quality social adult day services to seniors within the Capital Region.

Through a grant from the New York State Caregiving and Respite Coalition (NYSCRC), CSSC was able to expand respite services within the counties of Albany and Schenectady through the REST (Respite, Education and Support Tools) program. This program trains volunteers to provide adult day social programming in the home to the senior in need. The respite volunteers provide respite to both the member and caregiver, and provides each with a sense of purpose, continued independence and peace.


Bright Horizons provides caregiver support through its Caregiver Lending Library, making available resources through CDs, DVDs and books relating to taking care of a loved one, as well as resources relating to the caregiver taking care of themselves. We also hold an Alzheimer's Caregiver Support group, once a month, at The Beltrone Living Center. Caregivers may bring their loved one to Bright Horizons while they attend the support group meeting, thus receiving the respite care they need while knowing their loved one is safe.



Transportation Services

The Transportation Services Program provided by Colonie Senior Service Centers, Inc. enables older adults, aged 60 or greater, to get to medical appointments, senior dining sites, social adult day service programs, volunteer opportunities in the community, the pharmacy, the grocery store, social and life-long learning activities, as well as community and cultural events and run errands. In CSSC's forty-one years of serving seniors, Transportation Services has never been more important as seniors are eager to engage with their community. In a typical year, the Transportation Services Program provides over 25,000 rides to seniors with our fleet of 12 vehicles. In 2022, CSSC received one (1) new 12-seat bus, through a federal 5310 grant.

CSSC is proud to have dedicated and enthusiastic drivers who provide curb-to-curb Transportation Services, where a senior is picked up at the front door of their home and taken to the front door of their destination. When they are ready we pick them up and take the senior safely back home. CSSC's Transportation Services Program helps seniors in our community remain independent and active in the community.



Driver Fitness Center

Our Driver Fitness Center at The Beltrone Living Center works closely with other senior service providers and the law enforcement community to offer resources to assist older drivers to continue driving safely, longer and help maintain their independence and self-sufficiency.

The Driver Fitness Center, in 2022, conducted the Defensive Driving program endorsed by the American Safety Institute. Our classes were held twice a month at The Beltrone Living Center with over 530 senior drivers participating in the socially distanced classroom. These experienced senior drivers were updated on essential driving skills that help reduce risk, prevent accidents and allow them to continue to drive safely on our roads with confidence.



Senior Community Dining



In 2022, Colonie Senior Service Centers served 27,460 meals at five locations, as well as our Bright Horizons Adult Day Program. All neighborhood sites resumed in-person dining and twice per month musical entertainment. With the pandemic restrictions lifted, we saw the desire for seniors to reconnect socially with others in their community, resulting in more seniors participating in the Senior Dining Program. In 2022, the Senior Dining Program served more than 2,500 meals over the number served prior to the pandemic.

CSSC was proud to be able to provide a nutritious low to no cost meal to seniors in the community during a time of unstable supply chains and record high grocery prices across the nation.

THE CENTER at CSSC



In the fall of 2022, **THE CENTER** at CSSC celebrated its third year of serving the seniors of our community. What change we saw in those three years! In dreaming up **THE CENTER**, we wouldn't have imagined, couldn't have imagined, how the world would change, and how it would impact our programming. As we enter 2023, **THE CENTER** has 1700 members, and increase of 400 senior members since the beginning of 2022.

Last year, we saw incredible growth in our programs, and also saw the age of the seniors we serve change. As people retired after the pandemic, the demand for everything **THE CENTER** offers grew. The increase in younger seniors exploded, changing how we plan and what we plan. Our programming now includes club events such as mahjong and exciting outings like kayaking. Our seniors knit and quilt and paint in watercolors and also learn how to make monoprints and line dance, create mosaics and practice pilates. In short, we are offering a bit of everything, for all people.

At **THE CENTER** at CSSC, we believe that inside every person is an adventurer, an artist, and athlete, a lifelong learner and someone who needs to be around other people. We hope to nurture those inner beings and draw them out. We invite all seniors to be an explorer with us, be creative, meet someone new, and be part of an inclusive community.

Umbrella of Colonie



Umbrella of Colonie connects senior homeowners to a wide variety of home maintenance services, allowing them to continue to live safely and independently in their own homes. By utilizing the assets within our community, we connect senior homeowners with retired handy men and women who help perform simple home repairs at a very reasonable cost. The homes stay in good condition at a manageable cost, and relationships are forged between the handy people and the homeowners. Now in its 15th year, Umbrella of Colonie continues to improve and extend services to meet the needs of our constantly growing number of seniors in the Town of Colonie.

In addition, Umbrella of Colonie continues to assist with the annual Warmth of Winter fundraiser, which raises money to help seniors in the community with their winter heating bills. In 2022, with the incredible support of the our local community we raised enough money to assist over 200 senior households with their winter heating expenses.

Tool Box



Tool Box, which is an expanded service component of Umbrella of Colonie, is a volunteer run, donation based, tool resale shop. Created in 2015, Tool Box is located in The Hilltop Plaza, 143 Troy-Schenectady Road, Watervliet, in the Town of Colonie. Tools are donated by members of the community, cleaned and organized by volunteers, and sold at a highly discounted rate to the public. All proceeds from the Tool Box help low income Umbrella members with upkeep and repairs that are needed, but may not be easy to afford.

The Tool Box continues to grow and consists of volunteers who are dedicated, conscientious and enjoy the opportunity to create lasting friendships with other volunteers while connecting with members of our community who share their love of tools.

Volunteer Opportunities

CSSC is privileged to have 328 active AmeriCorps Seniors RSVP volunteers (RSVP and CSSC combined) who give freely of their time and talent to help seniors and their families each year. In 2022, nearly a hundred of these volunteers donated their time to CSSC's Senior Dining Program, Bright Horizons Adult Day Program, Tool Box and Senior Transportation Services, and also volunteered to help at various fundraising and community events. On average through CSSC, volunteers provided 534 hours per month, for a total of 6,408 hours of their time to support the Capital Region community.

CSSC, for the eighth year, is the Capital Region AmeriCorps Seniors RSVP sponsor. We provide diverse opportunities for senior volunteers age 55 and over by collaborating with 60 RSVP stations (organizations that include hospitals, non-profits, proprietary healthcare organizations, historic sites, social service organizations, educational institutions) throughout Albany, Rensselaer, and Schenectady counties. During 2022, RSVP seniors were able to return to their volunteer opportunities as RSVP stations continued reopening. RSVP volunteers make a difference for the many organizations they serve. They impact people's lives with their spirit and sense of responsibility, making things happen for the greater good of the community.

In October, we hosted a Fall Volunteer Opportunity Fair at The Beltrone Living Center to encourage seniors to return to volunteering in our community. This Fair gave area nonprofit organizations, like Shaker Heritage Society, Friends of Fiver Rivers, Alzheimer's Association of NENY, C.E.O, Eddy Village Green, the Pruyn House, SPHP, Grafton Lakes State Park, Hope 7 Community Center and The Joan Nicole Prince Home the chance to present their volunteer opportunities to hundreds of seniors who attended the event.



Independent Senior Living Communities

Colonie Senior Service Centers, Inc. currently offers three senior living communities that provide affordable housing to seniors so they may age in place in our community.

The Beltrone Living Center

Located adjacent to The Crossings of Colonie, The Beltrone Living Center, an affordable, 55+ housing community, opened its doors in 1999 with 250 apartment homes for independent seniors. The Beltrone Living Center is a truly unique community with numerous amenities. Residents do not have to leave the comfort of the building to get to the Lakeview Restaurant operated by Mazzone Hospitality, the Country Café, the Salon at Beltrone, library, billiards room or Bright Horizons Adult Day Services. Colonie Senior Service Centers' administrative as well as programs and services offices are located in The Beltrone Living Center. Hundreds of community events and activities are held at The Beltrone for older adults throughout the Capital Region to come together for a variety of reasons and interest.



King Thiel Senior Community

The King Thiel Senior Community, which opened in May 2017, is the newest and premier, affordable, 55+ independent senior living option in Colonie. This apartment community offers 96 one and two bedroom apartment options along with exceptional lists of amenities and features that make living comfortable and affordable for seniors seeking affordable housing. This housing community not only meets a long-awaited need, it also appeals to others who may be looking for a community center. The "Clubhouse" is for residents and community members to gather for activities, parties, classes and social gatherings. Included in the Clubhouse are a café, fitness center, library, lounge and many other features. Currently, The King Thiel Senior Community has an approximate five to seven year waiting list.



Sheehy Manor

Sheehy Manor opened its doors in 1998 to seniors over 62 years of age with limited income. Many original residents still live there today, a testament to the comfort and character of the facility. Sheehy Manor has become one of the area's premier residences for independent seniors, maintaining a long waiting list for interested future residents.



Community Support in 2022

During 2022, CSSC services and programs faced a vast increase in demand, as seniors yearned to re-engage with their community. We were able to support our senior community due to the generous support of the business community, foundations and individuals who believe in the mission of CSSC.
